**Listed Buildings Act 1990: Application for Listed Building Consent  
Relocation ('Demolition') and Renovation of the Statue to Sir Charles Mark Palmer**

Please find enclosed an application for listed building consent for the relocation (which technically constitutes a demolition) and renovation of the Statue to Sir Charles Mark Palmer. This application consists of:
